Can I pay my registration fee in euros?

Do I have to register if I am a presenter and/or speaker?

Yes, you are required to register to obtain CME credits.

Do I need to select the sessions I want to attend in advance?

Yes, it is important that during the registration process, you select all the sessions you plan to attend.

Where and when is the closing event being held?

The closing event will be held at the Smithsonian National Museum of Natural History on Friday, May 10, 2024, from 7:30pm–11:00pm.

I would like to attend the closing event. How do I purchase a ticket?

Tickets can be purchased through your meeting registration by adding the closing event to your itinerary. The cost of the ticket will be added to your cart at checkout. Tickets are \$125 (ages 16+), \$62.50 per child (ages 11-15), and no charge for children under the age of 11.

Is transportation provided for the Closing Event?

Yes, transportation is included in the price of your ticket.

What is the cancellation policy?

Full refunds will be provided less a processing fee if received in writing to Respeto@posna.org by the date listed

below. No refunds will be granted after April 30, 2024. Registrants will receive confirmation and a refund within 14 days of receipt of their cancellation notice.

February 2–April 9, 2024 - less a 20% of registration processing fee April 10–April 30, 2024 - less a 50% of registration processing fee May 1, 2024–No refunds

Can I pay by check?

Podium presenters must present onsite at the meeting. ePoster presenters, though registration is required, are not required to attend in-person. If you are unable to attend, you must designate another *eligible* presenter from your co-author options. If you are unable to find a replacement that meets the criteria for presenters, you will not be able to present an abstract the following year. Urgent issues will be handled at the discretion of the Program Committee Chairs.
