2021 VIRTUAL MEETING **FREQUENTLY ASKED QUESTIONS**

Registration/Payments:

What is the fee for the Virtual Meeting and what is included?

The fee for the Virtual Meeting is \$400 for a POSNA member and \$500 for a Non-POSNA member. **ALL** sessions will be broadcasted live (access to all session rooms). Virtual attendees will have to tune in at the scheduled time to view presentations.

Will I be able to view the virtual meeting at any time on any day once it is open?

The Virtual Meeting will follow the live meeting schedule. The pre-recorded content includes symposia, Young Member Forum, Video abstracts, and ePosters.

When is the registration deadline for individuals who want to attend the Virtual Meeting?

The deadline to register for the Virtual Meeting is **Monday, May 10th, 2021**.

Can I pay for multiple attendees on one company check?

Yes, however, you must include the attendees' names or POSNA ID's on the check.

I am unable to log into my member account to register. What do I do?

Your email address is your username. Then click "forgot password" to receive an email on how to reset it and log in. If you still cannot log in, please [contact us](#) and we will get back to you as soon as possible. Be sure to use Chrome as your internet browser.

Do I have to register if I am presenter and/or speaker?

Yes, you will be required to register for the in-person event or for the Virtual Meeting.

Can I change my registration to the Virtual Meeting if I have already selected in-person registration?

Yes, you may change your registration to the Live Virtual Meeting. To change your registration, you will need to contact the POSNA office at posna@posna.org.

When is the deadline for presenters or speakers to register for the Annual Meeting?

The deadline for presenters and speakers to register for the Annual Meeting is **Thursday, April 22, 2021**.

Will the Virtual Meeting count towards my Meeting Requirement?

How do I access the meeting virtually?

You will be emailed a link to the email on file. This link will allow you to login and view the meeting.

What will be available on the virtual meeting?

The full live meeting (during session times) and pre-recorded sessions (symposia, narrated ePosters, video abstracts, Forum).

Do I need to select the sessions I want to attend?

No, you will have access to all sessions, and you will be able to choose what best fits your schedule that day.
